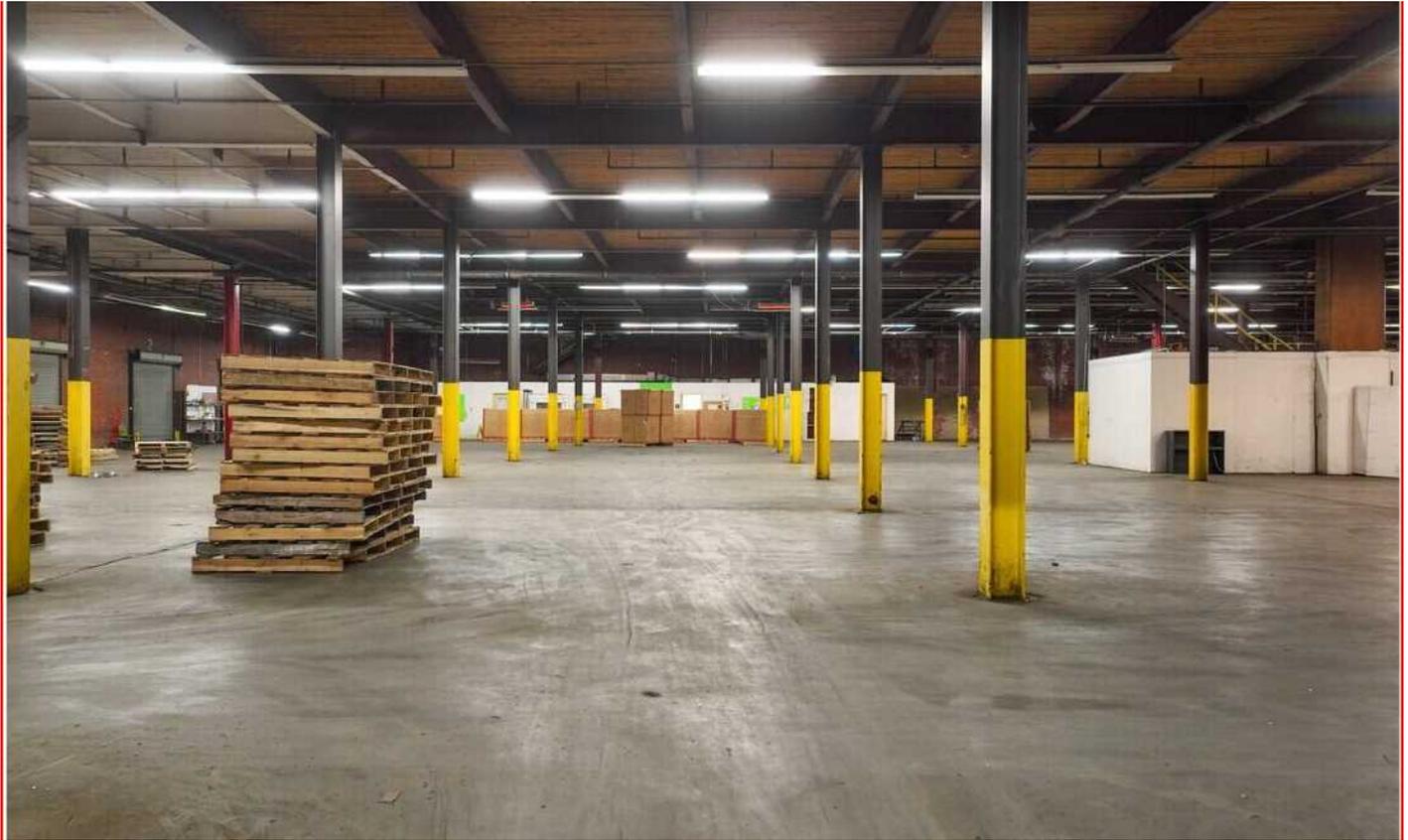

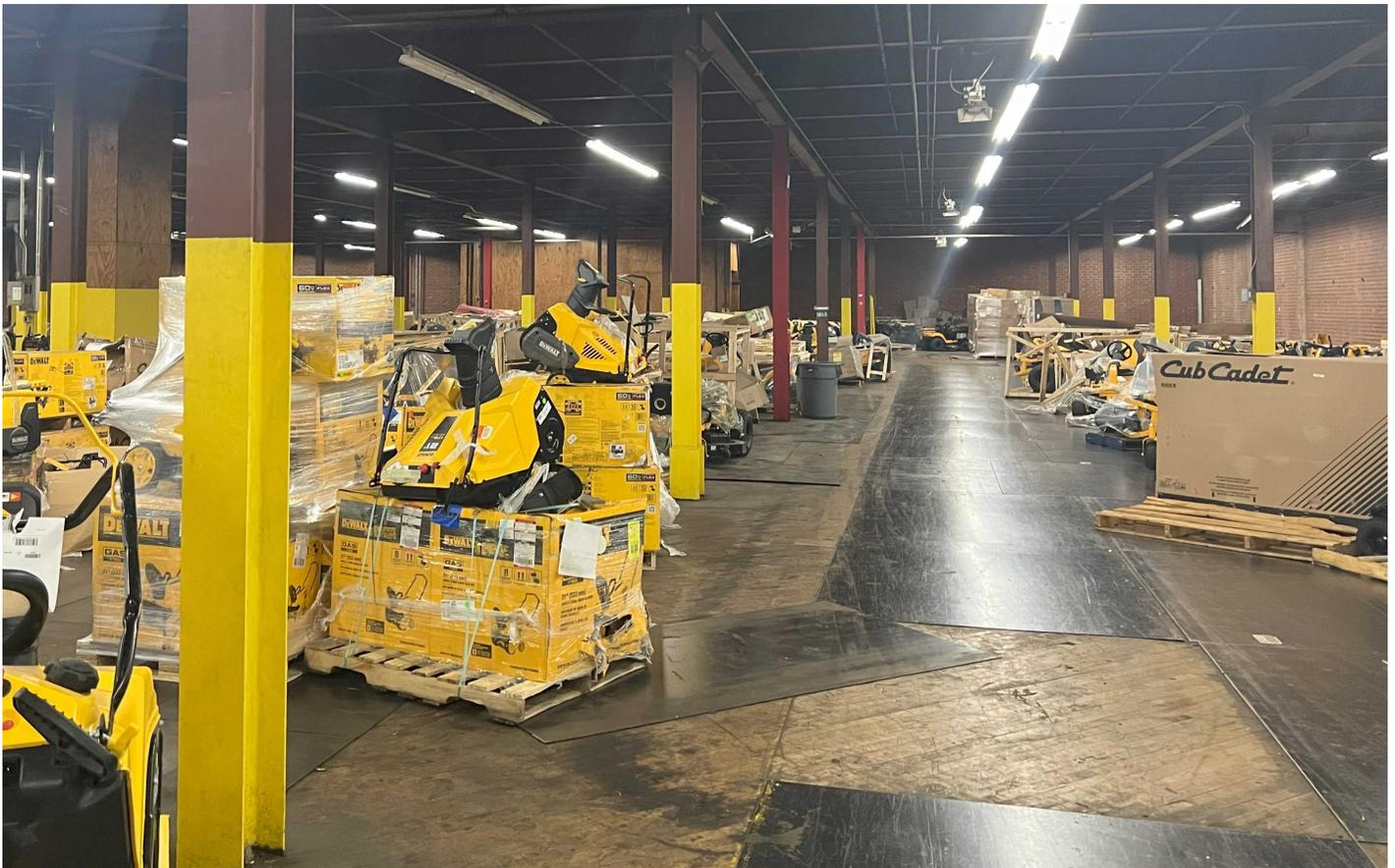

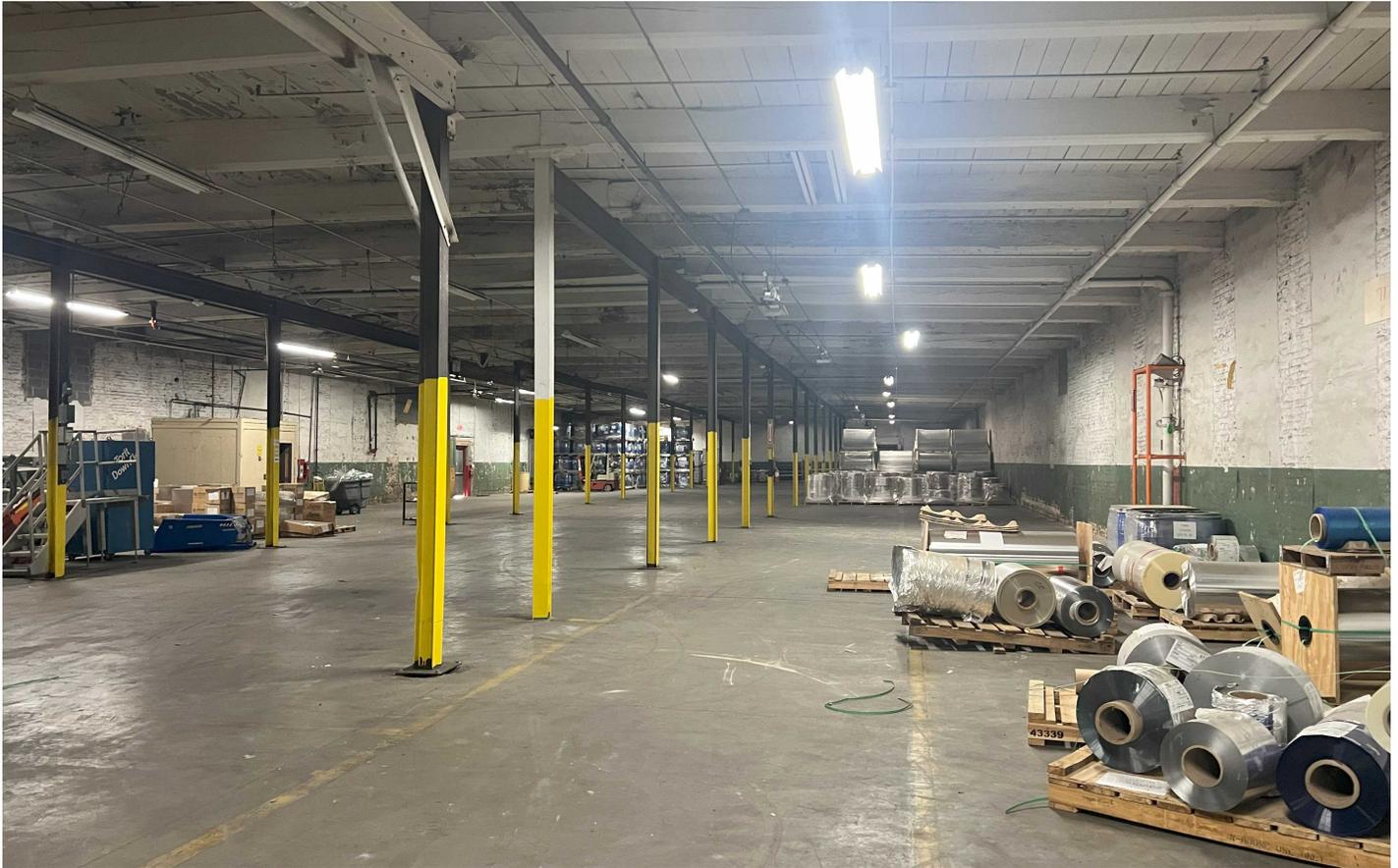
Location Overview

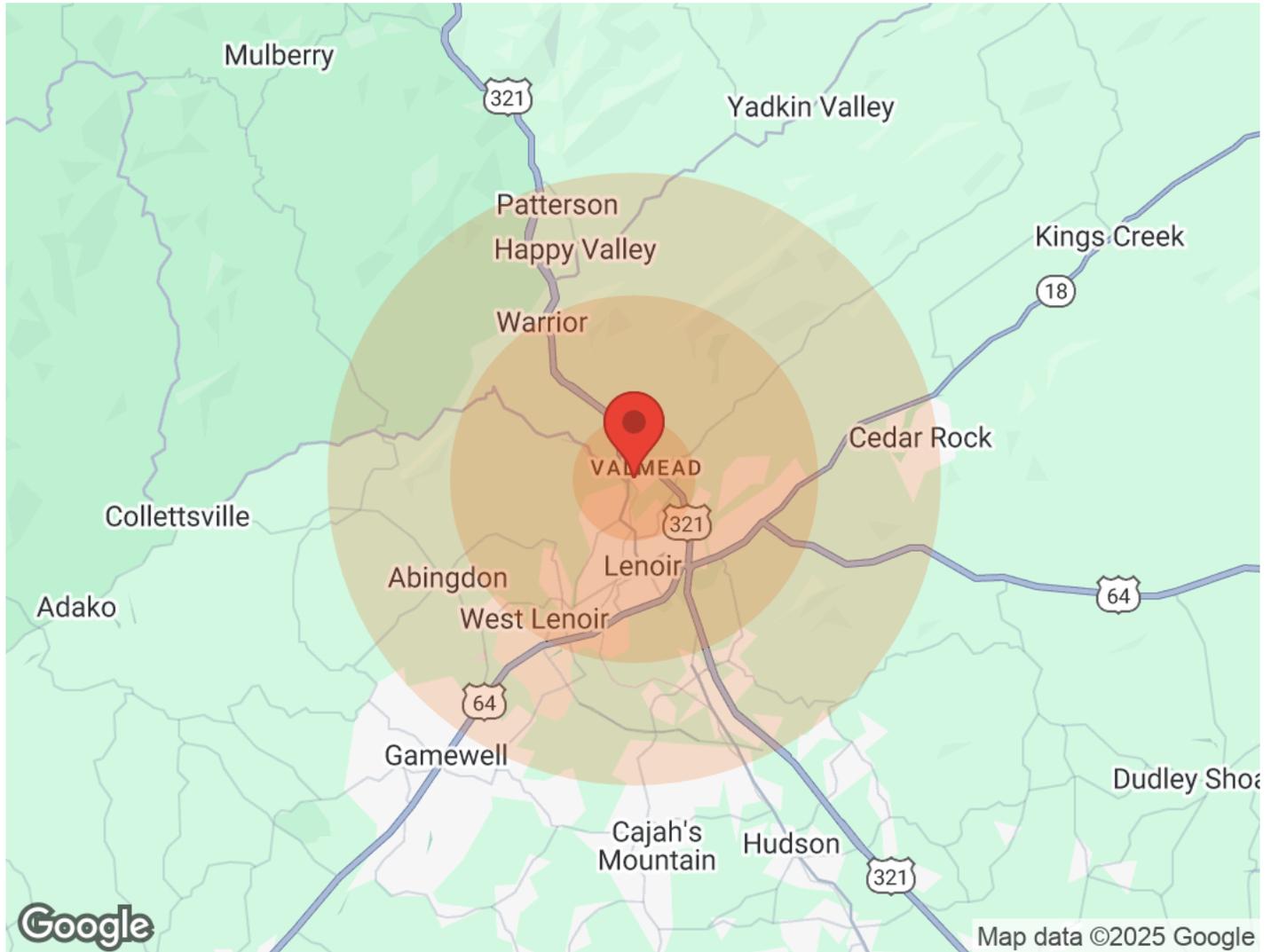
REGIONAL MAP
